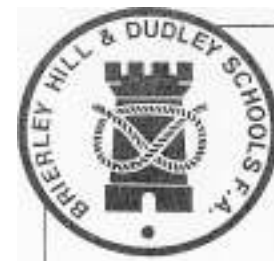
### RULES:
